2. ECMAS accepts no responsibility whatsoever for any problem resulting from incorrect or incomplete entries.
3. The Auditors shall not be required to provide reason for any decision in respect of the completion
4. ECMAS reserve the right to cancel, modify and amend the competition rules at any time if deemed necessary in its option and if circumstance beyond their control arises.
5. By accepting the nomination to the ECMAS each nominee is deemed to have accepted these rules
6. The Auditors shall have the right to disallow entry form in the following instance :
  - a. The nominee provides insufficient information to verify the entry.
  - b. No contact is readily available on the entry form
  - c. The entrant is not eligible to enter
